HOW TO REGISTER

Registration can take place at any time.

If you choose to apply **online** and upload your documents, you will need to complete your application by making your payment by **credit/debit card**.

If you choose to apply **online** and **post** your documents, then you may complete your application by using any of the following methods of payment:

- credit/debit card
- cheque
- banker's draft
- postal order.
